FEEDING DIRECTION

Feed Excel Sure and Sound at a rate of 2% of bodyweight, over a 2 week period slowly increase to 2.5— 3% of bodyweight as the calf acclimates to the feed. Feed continuously in complete feed to provide not less than 100mg nor more than 360mg /hd/day. Always provide high quality hay and always provide fresh water daily. Put out a Excel Coolyx Stress tub for fly control and digestive health, along with top dressing with Excel Show Supplement.

Caution: The safety of Lasalocid for use in unapproved species has not been established. Do Not allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal.

Warning: A withdrawal period has not been established for this product in pre-ruminating cattle. Do Not use in calves to be processed for veal.
