FEEDING DIRECTIONS

Feed 12% Fat and Happy continuously to provide not less than 100 mg nor more than 360 mg/hd/day of Lasalocid. Feeding at a rate of 6.6# to 24# of feed will supply the Lasalocid requirements. Feed at a rate of 2-3% of body weight as a rule of thumb. Provide fresh water daily and suggested to place a salt block in pen to help keep hydrated.

WARNING: A withdrawal period has not been established for this product in pre-ruminating cattle. Do not use in calves to be processed for veal.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid as ingestion could be fatal.
